Ms. Hibbard is an experienced international mining CEO with over 22 years of experience in six publicly traded Canadian mineral exploration companies. Notable achievements include negotiating the acquisition of the Detour gold mine property for Pelangio Larder Mines and participating in founding Detour Gold Corp., a Canadian gold mining company which attained a market capitalization in excess of \$5 billion. Ms. Hibbard also negotiated the acquisition of a district size land package in Ghana, adjacent and on strike with the 70-million-ounce Obuasi Mine owned by AngloGold Ashanti and currently being redeveloped. Ms. Hibbard has over 30 years of experience spanning all facets of the mineral resources industry from early-stage exploration to mine development and production. She has a track record of successfully identifying and developing mineral projects by situating them strategically in the market cycle in order to maximize shareholder value.
